

HOUSE RULES WALDBÜHNE BERLIN

The house rules apply to the Waldbühne Berlin (hereinafter referred to as Waldbühne). **The house rules apply to all persons staying at the Waldbühne**, especially to visitors of events. Additional event-specific regulations may be announced by means of notices, on the Internet, and on admission tickets. The Waldbühne is subject to the domiciliary rights of CTS Eventim AG & Co. KGaA, which exercises domiciliary rights together with the respective event organizer. The domiciliary rights will be enforced by the appointed security service. **Possible consequences of a violation** of these house rules may include expulsion from the Waldbühne, exclusion from the event, the issuance of a house ban, claims for damages and criminal prosecution. Refund of admission fees is excluded in these cases.

Only visitors with a valid ticket or guests of the organizer are allowed **to stay at the Waldbühne** during events with ticket sales. Visitors must take the place indicated on the ticket for the respective event and use only the designated entrances. Upon leaving the place of assembly, the admission ticket loses its validity.

All facilities of the place of assembly are to be used with care and consideration. Within the place of assembly, everyone must behave in such a way that no one else is harmed, endangered or obstructed or inconvenienced more than is unavoidable under the circumstances. It is forbidden to defecate outside the toilets provided for this purpose.

Persons who are recognizably under the influence of **alcohol or drugs** will be excluded from the event and must leave the place of assembly. Rejected visitors are not entitled to a refund of the admission fee. **The provisions of the Youth Protection Act apply**. Further restrictions and special regulations apply in the event of express notification on the Internet and corresponding notices at the box offices and admission areas. In addition, more stringent regulations of the respective organizer may apply.

Stairs, stairways and paths must be kept clear at all times for safety reasons. For safety reasons, areas of the Waldbühne may be closed and evacuated. Corresponding requests must be complied with immediately.

It is not permitted to bring bags and backpacks larger than DIN A4 (21.0 cm x 29.7 cm) into the Waldbühne. Bags larger than DIN A4 must be handed in in front of the Waldbühne at the usual local charges. For security reasons, **additional body and bag checks** may be ordered. Visitors who do not agree to the seizure of objects that could endanger the event or visitors by the admission or security service will be excluded from the event. Rejected visitors are not entitled to a refund of the admission fee. No liability is accepted for valuables, money, keys in bags and backpacks handed in!

It is not allowed to bring food and drinks. Exceptions are a 0.5L Tetra Pak or a 0.5 PET bottle. Possible exceptions to this prohibition for special events will be announced in advance; even in these cases, bringing food and beverages is only allowed for personal consumption. Bringing alcoholic beverages is generally not permitted.

Bringing in and carrying the following items is additionally prohibited:

- Drugs of any kind in accordance with the Narcotics Act (BtMG).
- Bulky items, such as: Picnic baskets, baby carriages, helmets
- Glass containers and bottles as well as beverage cans
- Containers made of fragile, splintering or particularly hard material
- objects and things which, if thrown, could cause bodily injury to persons
- Stick umbrellas and other umbrellas with the exception of pocket umbrellas
- Mechanically and electrically operated noise instruments
- Technical devices: Notebooks, tablets, video, photo and sound recording devices, large power banks with the exception of cell phones
- Animals with the exception of guide dogs
- Fireworks, rockets, Bengal fires, smoke powder, sparklers, flares, laser pointers, pyrotechnic objects

- Gas spray bottles, corrosive or coloring substances or pressurized containers for highly flammable or harmful gases, with the exception of commercially available pocket lighters

- Weapons, protective weapons, weapon-like objects
- Racist, xenophobic and radical propaganda material as well as corresponding symbols (flags & banners)

Right to one's own image: If any images are taken by employees of CTS Eventim AG & Co. KGaA, by the organizer or commissioned companies, photographs, film and/or video recordings are made in the area of the place of assembly for reporting or advertising purposes, the recording activity may not be obstructed or impaired in any other way. All persons entering or staying in the place of assembly are informed by these house rules that photography, filming and video recording may be carried out in the area of the place of assembly. By entering the place of assembly, those who can be recognized in such recordings consent to these recordings being used for both reporting and advertising purposes.

To reduce the risk of harm, the use of hearing protection is recommended at **music events** where high volume is expected.

House bans apply to all current and future events at the Waldbühne. For the lifting of the house ban, a written application with justification is required, on which a decision will be made within 3 months.
